

Authors—**HELP!** Just before sending your report to the Publications Group, please check ✓ the following items:

For ALL reports:

- “Mill” copies of text, tables, and all illustrations are up to date and plainly identified.
- All type is doublespaced (Open-File Reports excepted).
- Authors’ complete mailing address(es) are shown (except for USGS authors in USGS reports).
- Cooperative note and acknowledgments are included, if appropriate.
- All references cited in text are shown in the reference list.
- All parts of the report are attached, including any oversize plates and tables.
- Technical reviewers’ copies are attached.
- Title and authorship on the front of this form are correct and current and match the title page.
- Complete account or WCF number (all nine digits) is shown.
- Geographic area of study, if any, is named in the title. (If the report concerns an area that is not named in the title, please attach an explanatory note.)
- Team Chief Scientist and all technical reviewers have signed and dated this form.
- Copies of permission to use confidential data and (or) copyrighted material are enclosed.

For all USGS books and maps:

- Description of software used to prepare illustrations, including dpi of all scanned material.

For USGS books and maps with text:

- Report is described succinctly in:
A note of 75 words or less for the
“Monthly List of Publications of the
Geological Survey” AND
A note of 40 words or less for the
Superintendent of Documents.

For all USGS books:

- Title page includes a 5- to 25-word descriptive note (except Circulars) that is not just a restatement of the title.
- All section headings, illustrations, and tables are listed in the Contents section of the report.
- An Abstract is included.

EXPLANATORY FOOTNOTES FOR MANUSCRIPT REVIEW AND APPROVAL SHEET

¹All USGS reports must have a signed Publication Plan before acceptance by the PG for editing. Please include a copy of the Publication Plan. Use the PG number on the Publication Plan in the box labeled “FOR PUBS GROUP ONLY”.

²Please type or print clearly.

³A mail stop and extension number will suffice for authors at the same center with the servicing PG. Out-of-town authors please note whether the telephone number is FTS or commercial.

⁴For journal reports, show name of journal.

For chapters in books not published by the USGS, show book title, publisher, and volume editor.

For abstracts and other reports prepared for meetings, show sponsoring organization and name, date, and place of meeting.

For other types of report, explain the form of publication as well as possible.

⁵The PG’s give priority treatment to reports that have reasonable, legitimate deadlines. Except for abstracts and “no edit” outside reports, reports with deadlines should be accompanied by a memo from the author’s Team Chief Scientist requesting priority. “Deadline” shown here should be the date by which the author must have the report printed and available to the public.

⁶Generally, a full signature denotes approval, whereas initials mean only that the report has been seen.
